The MEGGLE baguette with herb garlic butter is a prebaked baguette comprising to baguette and original MEGGLE herb butter. After a short baking, the "MEGGLE baguette herb butter" is ready to eat.

Baking Application: Take the product out of the packaging and put it into the middle rack in the preheated oven at 200°C. Bake it for approx.9 -11 minutes until the desired degree of browning is reached.
